



NZPCA Body Protector Policy

August 2020

REQUIREMENTS AT PONY CLUB

Designed to absorb impact from a fall or kick from a horse, body protectors are compulsory at Pony Club in the cross country jumping phase of certificates or when practicing cross country jumping during rallies and other activities e.g. camps or at any competitions involving cross country jumping.

Wearing a body protector for jumping at all levels is strongly recommended.

As of 1st August 2020 there is a minimum standard of body protector required.

LIFESPAN OF A BODY PROTECTOR

Body protectors should be replaced at least every three to five years, after which the impact absorption properties of the foam may have started to decline.

If you should have a heavy fall, your body protector should be checked immediately for dents. The foam will expand back to its original shape within 30 minutes; but if a dent is showing on examination, then it is likely that this part of the garment has lost its impact absorption properties and should be replaced.

Hidden damage that a body protector may have sustained is also a good reason for avoiding second-hand garments or those with unknown histories.

MINIMUM STANDARD OF BODY PROTECTORS

From 1st August 2020, all body protectors must meet **one** of the following standards:

BETA EN13158 2009(or newer) Level 3

ASTM F1937.

These products show that they are compliant with the required standards by displaying one of the following labels on the garment.

TAGGING OF BODY PROTECTORS

To assist Stewards and Gear checkers at Pony Club events and activities, the NZPCA have introduced a tagging system to enable them to quickly identify body protectors that have been checked to ensure they are of the correct standard.

All body protectors worn by Members at Pony Club events and activities in which a body protector is mandatory must have on them an NZPCA Approved Body Protector Tag which is red.

- Only body protectors that meet the NZPCA approved standards (see above) can be tagged.
- Once tagged – the tag must not be removed
- If there is no tag present – the body protector must be checked and tagged before the rider can participate in any Pony Club event or activity
- Only the Head Coach/Chief Coach (Clubs without Branches) or their appointee can attach NZPCA Approved body protector Tags.
- NZPCA Approved Tags can be purchased from the NZPCA website, via the EShop, or by contacting the NZPCA Head Office

The tag should be placed on the front lower part of the body protector, preferably on the most solid piece of material available, avoiding mesh coverings where possible.

Care must be taken when attaching the tag as it is fitted with a security cut so that it cannot be re-used.
