<ul style="list-style-type: none"> • Combinations for Classes 1 - 6, who have completed at a higher level or been placed 1st, 2nd, or 3rd in four (4) events at that level, may ride in that level with 20 penalty points. • Clevely Cup -- Best-placed WPC rider after Dressage (must compete in all phases). 			

CONDITIONS

- Run under NZPCA Rules.
- Competitors and spectators enter grounds at their own risk. All dogs must be kept on leash.
- WPC reserves the right to alter or amalgamate classes; entries may be limited in all classes.
- GEAR CHECKS ARE COMPULSORY for EACH of the three elements. Medical Arm bands are compulsory for jumping phases.**
- APPROVED helmets must be worn in all phases and to be worn at all times whilst mounted.
- No commanded tests. Whips may be carried in all classes however the overall length including flapper must not exceed 75cm
Spurs are not to be worn in dressage phase for class 5 & 6
- Eliminated riders in cross-country phase may continue but **MUST give way to other riders.**
- All classes receive rosettes to 6th place (subject to number of entries). Classes 1 & 2 receive prize money to 4th place:
1st \$ 40, 2nd \$ 35 3rd \$ 30, 4th \$20 (If less than 8 entries only 1st & 2nd prize money will be given/less than 5 only 1st)
- Protests must be lodged with the Secretary (in writing) within 15 minutes after placings being posted together with a \$20 fee, refundable if protest upheld.
- Prize giving for ALL Classes will be at the conclusion of the event.
Riders to be unmounted and in **correct attire** otherwise prizes will not be presented with the exception of Zilco Series Placegetters that are to be mounted and in correct attire.

- Entries with a Fence Judge Nominated will be given preference. There will be a draw for a \$50 Voucher for Fence Judges.**
